

**Solar Depot LLC Agreement for PowerClerk Access  
for the California Solar Initiative (CSI) Rebate Program**

This Solar Depot LLC Agreement for PowerClerk Access (“Agreement”) is made as of \_\_\_\_\_ (fill in date) by Solar Depot LLC, a California corporation, (“Solar Depot”) and \_\_\_\_\_, a \_\_\_\_\_ corporation (fill in your business name) (the “Dealer”).

1. Dealer hereby authorizes Solar Depot to have access to Dealer’s PowerClerk account [No. \_\_\_\_\_ ] in order for Solar Depot to prepare the necessary documents for the California Solar Initiative, CSI, (as defined below) rebate application on Dealer’s behalf. Dealer understands and agrees that Solar Depot will have full, unrestricted access to all of the Dealer’s applications in PowerClerk created before and after this Agreement until the Dealer provides written notice to Solar Depot and the PA (as defined below) to cancel this authorization as described in paragraph 3.
2. Dealer will provide to Solar Depot the email that Dealer will use for the PowerClerk sign-in, so Solar Depot can also use it. Upon approval by the California Solar Initiative (CSI) Program Administrator (PA), the PA will grant Dealer login information, which login information Dealer shall forward to Solar Depot, by which Solar Depot will have access to the PowerClerk system.
3. If Dealer at any time decides to stop utilizing Solar Depot’s rebate filing services, Dealer will notify in writing Solar Depot and the CSI PA to cease Solar Depot’s access to the Dealer’s PowerClerk account.
4. The undersigned executes and delivers this Agreement as of the date written in the signature lines below. By executing and delivering this Agreement, Dealer certifies that the Host Customer, defined as the utility customer at location of solar system installation, will be or has been notified of this Agreement between Dealer and Solar Depot, and that Solar Depot will have full, unrestricted access to the Host Customer data.
5. By executing and delivering this Agreement, Dealer agrees that the CSI Program Administrator, PA, reserves the right to verify any authorization request submitted before releasing any information or taking any action on Dealer’s behalf. Dealer hereby releases, holds harmless, and indemnifies Solar Depot and its directors, officers, employees, agents and representatives from any liability, claims, demands, causes of action, damages, or expenses resulting from any actions taken by Solar Depot pursuant to this Agreement. Dealer hereby releases, holds harmless, and indemnifies the Utility and its directors, officers, employees, agents and representatives from any liability, claims, demands, causes of action, damages, or expenses resulting from: 1) any release of information to Solar Depot pursuant to this Agreement; 2) the unauthorized use of this information by Solar Depot; and 3) from any actions taken by Solar Depot pursuant to this Agreement.
